

CLUB RULES

1. No alcoholic beverages are to be brought onto any Miami View Facilities or food brought into club house.
2. The use of recreational marijuana is prohibited on Club property.
3. Hunting is prohibited on Club property.
4. Employees shall not be reprimanded by members or guests.
5. Complaints of any kind, including those as to the conduct of employees, shall be made in writing to any member of the Board of Directors. Said complaint will be forwarded to the appropriate committee chairperson for consideration and/or investigation and a response will be made to the member. Only signed letters will be considered.
6. Parents are responsible for the supervision of their children within the boundaries of the Club.
7. No subscription paper shall be circulated, no donations or subscriptions solicited, and no article exhibited for sale in the clubhouse or on the grounds without written permission from the Board of Directors.
8. Dogs or other pets are not permitted on any part of the grounds or in the club house.
9. Guests must always be in the company of their host member.
10. Guests who are residents of metropolitan Cincinnati, may not use the golf course more than twice each month, unless they are members of another golf club in the Cincinnati Golfers Association. Non-Resident guests are not restricted as to the number of times they may use the course as long as they are accompanied by a member. BOTH THE GUEST AND THE MEMBER MUST SIGN IN.
11. Guest fees are: \$56.00 Weekdays; \$61.00 Weekends; \$32.00 for 9 holes; December – February \$46.00 for 18 holes, \$27 for 9 holes; if on temporary greens, \$20 for 18 holes; \$10 for 9 holes; Grandchildren, under the age of 16 when accompanied by a grandparent, \$10.00 for 9 holes during slow periods.
12. A youth under the age of 16, playing under family privileges, may bring another youth as a guest for up to 18 holes for \$15. The guest can play only twice per month.
13. Women's sleeveless shirts must have a collar or mock crew neckline and other collarless shirts must have sleeves.
14. Players should be properly attired at all times. Men must wear a collared shirt or a mock turtleneck shirt. Women are not permitted to wear halters. All players' shorts must be of appropriate length.
15. Players wearing high-heeled, rippled, or cleated shoes are not permitted on the course.
16. Do not throw paper cups, cigarette packs and other litter on the course.
17. All members, qualifying family members, and guests must sign in prior to the start of each round. Those in the Handicap System must post each 18 hole adjusted score.
18. Members who fail to pay their restaurant charges on the day they are incurred will be notified the following day by email of their balance. If the member disputes this charge they have 72 hours to address this issue with the restaurant operator. Members who fail to address within 72 hours forfeit any future right to challenge this particular charge. Members who frequently fail to pay on a daily basis can be required by the operator to prepay on their account prior to being

served. All disputes between the operator and members shall be settled by the involved parties. All unpaid charges, on the last day of each month, will be moved from the open status to an accounts receivable file. Members having balances in accounts receivable, will be mailed a statement within the first 5 working days of the new month. 20% will be added, consisting of a 15% gratuity and 5% for service charges. The restaurant operator will be responsible for preparing of the statements, mailings and posting of all payments to the member's account. The member has 10 days to make payment after receipt of their statement or they shall be considered delinquent. If the account is still delinquent after 30 days, the member's membership, with all its privileges, will be suspended until the account is settled as set forth in the Constitution, Article II Section 1.

19. Fishing privileges are for members, members' families, and up to three (3) guests. Guest fee is \$3.00 per guest. Fishing cart rental is \$3.00. Fish at own risk. No one under the age of sixteen is allowed to fish unless accompanied by a member.
20. Smoking is not permitted in the Club House, Grill Room, Pavilion, or Pro Shop at any time.
21. Smoking on the patios is prohibited at all times.
22. Soft Spikes are required all year round.
23. All golfers are to start on front nine unless given permission by the Pro Shop. Special events shall serve as an exception to this rule.
24. Only two (2) motorcarts are permitted per foursome, when national emergency not in place.
25. All members and guests must display a bag tag except for designated tournaments.
26. Lightning Siren Rule – Upon hearing the siren for lightning in the area, all members and guests shall immediately stop golfing and seek shelter at the clubhouse or a shelter on the course. No play or practice is allowed until the 'all clear' announcement is made by the Pro Shop.

Rules/Violations

Violation of club rules will be disciplined as described in the Constitution, "Article II, Section 1, Part 7. The Board of Directors may expel or suspend!
